National MANRRS Professional Officer Candidate Application

The purpose of this application is to provide the nominating committee with information on each nominee and to provide the opportunity for each nominee to express his or her desire and commitment to serve the National MANRRS Organization as a Professional Officer. In addition, the information is collected to facilitate the conference activities associated with the national MANRRS officer selection process.

Minimal Requirements:

- Completed a B.S and at least eight years in a leadership role or Completed a M.S. and at least four years in a leadership role
 - (Identify leadership roles within your professional and personal realm)
- Each nominee must be an active member in good standing, and meet the requirements for active membership during the time he or she serves as a national officer
- Willing to complete a background check due to engaging with vulnerable audiences

CONFERENCE REMINDERS

Candidates will go through the final nomination process at the 35th Annual Career Fair and Training Conference in Minneapolis, Minnesota April 1st through April 4th. **CANDIDATES ARE RESPONSIBLE FOR ALL TRAVEL RELATED EXPENSES.**

ONCE ELECTED, the new national officers must remain through Sunday morning, April 7th for a brief orientation meeting. In addition, newly elected officers must attend National Officer Training and Leadership Development Programs throughout the year: May 13-17, 2020 in Atlanta, GA, Professional Officer Training at the end of July 2020, August 6-9, 2020 (location TBD); January 7-10, 2020 in (Location TBD); and the 36th Annual Career Fair and Training Conference in Atlanta, GA. The candidate should plan to attend bi-weekly teleconferences and other activities throughout the year as well. MANRRS will cover travel related expenses to approved events.
