### **Position Description:**

The project will entail planning and conducting lands and realty existing rights/uses inventory for the Cotoni-Coast Dairies unit of the California Coastal National Monument in Santa Cruz County, California. Work will focus on locating and assisting with recording of existing land uses present on the Cotoni-Coast Dairies property. Many of the land rights/uses have title records documentation, but have limited locational data (e.g., lack of location maps). Workload would be divided between: Title Document Review (easements, deeds, grants, right-of-ways); Case file research/review; Field inventory; Recordation; project documentation; GIS data collection and management.

### **Position Description:**

The Ord Mountain (OM)/Newberry Rodman (NR) effectiveness-monitoring project consists of intense survey of previous restoration, signing, route maintenance, fencing, and management activities in these two subregions of the West Mojave Plan area (WEMO). In 2017, the BLM Barstow FO redirected funding from an existing OHMVR grant to install route signage to WEMO protocol in the Ord Mountain sub region. This work took place in anticipation of the translocation of hundreds of threatened Desert Tortoise from the expanded 29 Palms Marine Corps base. Later in 2017, Barstow FO staff further strengthened the signing in the area by marking those closed routes that were not in compliance.

### **Position Description:**

The Bakersfield Field Office proposes to hire a Resource Assistance Intern to assist the Resources Division with maintenance activities during the summer of 2019. Should the intern's performance prove satisfactory, the office would convert the intern to a permanent WG-4749-09/10 Maintenance Mechanic with job duties associated with weed abatement, campground maintenance, recreation site maintenance and public contacts, range improvement installation and maintenance, equipment operation, water testing, condition assessments, electrical, painting, plumbing, fence repair, basic construction work, welding, masonry and cement work. The goal of this project is to reduce the backlog of routine maintenance within the Bakersfield Field Office. Specifically, the intern will work with the current resource personnel to maintain campgrounds (including potable drinking water systems, trash bins and clean bathrooms) and day use areas, install signs, maintain roads and trails and other BLM infrastructure. The intern would also coordinate closely with the Field Office's Civil Engineer and be taught how to conduct annual condition assessments as prescribed by the Facility Asset Management database. The intern would learn start-up and shutdown procedures for water supply systems. The intern would also serve as a field going contact.

The Bakersfield Field Office proposes to hire two Resource Assistance Interns to assist the Resources Division with project permitting activities during the summer of 2019. Should the intern's performance prove satisfactory, the office may convert the intern to a permanent GS-0193-7/9/11 Archeologist position or a term GS-0193-7/9/11 Archeologist position focused on a large EIS project. Interns will perform professional work in heritage resource management within the framework of BLM's multiple use mission. Primary focus will be on oil and gas permitting activities with additional project opportunities related to grazing, recreation and rights of ways. Ensures compliance with Section 106 and 110 of the National Historic Preservation Act. Consults with BLM management, other archaeologists, land owners, state government officials, tribal governments to provide information. Writes and prepares heritage and paleontological resource input for portions of environmental documents such as environmental assessments and planning documents.
