#### **Position Description:**

### **Position Description:**

Complete surface compliance inspections for realty fluid mineral actions. Both realty and fluid mineral staffs at the Rock Springs Field Office (RSFO) utilize the summer months to complete surface compliance inspections in the field. With the many authorizations in the FO, existing vacancies and limited field season it is difficult to complete inspections. For the fluid minerals staff more follow-up inspections are needed to adequately address whether items identified in initial inspections have been complete appropriately. For realty staff similar issues exists but also the number of authorizations needing compliance inspections is large. A DHA intern dedicated to follow-up fluids surface inspections and addressing the large number of realty inspections.

### **Position Description:**

In 2017, Cody Field Office obtained ~ 300 acres of 1.2 cm ground sample distance (GSD) orthoimagery and digital surface model (DSM) through an Unmanned Aerial System (UAS) mission. Additionally, we coordinated with US Fish and Wildlife Service to obtain ~ 1,000 acres of overlapping 3.5 cm GSD orthoimagery and DSM obtained with a general aviation platform. Data were captured in order to identify, delineate, and document a large-scale, surficial stone feature, cultural landscape. We propose to analyze these newly acquired data. We seek to utilize Direct Hire Authority for Resource Assistant Internship Programs to advertise, recruit, and hire a successful candidate.

#### **Position Description:**

The Bureau of Land Management's National Historic Trails Interpretive Center is seeking a capable, self-reliant and detail-oriented intern to compose an unprecedented research collection of documents, maps, photographs, reminiscences, historic newspaper accounts, and contemporary interviews relevant to a significant battle of the Plains Indian Wars from July, 1865. The battle site exists on BLM-owned lands west of Casper, Wyoming. Extensive but fragmented documentation of the battle is known to exist in various locations in the west and in several university archives across the nation; however, there is no single repository for all known materials of import that can inform BLM managers and interpreters about the battle in a credible, comprehensive way. The collection that results from the intern's work as outlined below will serve internal and external researchers, land managers, and interpreters for decades to come, and is vitally important to an imminent Environmental Assessment of the battle site, which - by consensus of all researchers since the 1920s - is the burial site of nineteen United States Army cavalrymen that died in the fighting. Physical location of their common grave is a high priority in the EA process.
